SWEEPSTAKES DESCRIPTION. The Sweepstakes takes place at the Mouser IoT Day Show on November 10th in Mexico City (Hotel W) and November 12th in Guadalajara (Hotel Hilton Midtown) (the "**Trade Show**"). The sweepstakes begins on November 10th, 2025 in Mexico City at the trade show and ends at its conclusion on November 12th, 2025 in Guadalajara at the trade show (the "**Promotion Period**").
